### LEGISLATIVE UPPATE

#### **California News:**

In a historic Medi-Cal budget bill, California included in the 2023-2024 budget some exciting news for care of women and birthing people. January 1, 2024, Medi-Cal provider rates will be increased to at least 87.5% of Medicare for primary care, non-specialty mental health services, and maternity care, which includes an increase in the global obstetric codes. This Medi-Cal rate increase will be the largest in California history. It will be an annual appropriation of \$1.38 billion in primary care rate increases, \$1.15 billion in specialty care rate increases, \$700 million to increase emergency department access (including \$200 million for emergency department physicians), at least \$500 million for family planning and reproductive health care, and \$600 million for behavioral health facilities, including increasing inpatient psychiatric beds (McCue, K. 2023. ACOG District IX community digest.)

#### **National News:**

As of June 27th, the Pregnant Workers Fairness Act took effect. This legislation was a cumulative effort of over ten years to require employers to provide accommodations for pregnancyrelated medical conditions including childbirth, postpartum recovery, lactation, pregnancy loss, postpartum depression, as well as time off to access abortion care. It nullifies a prior requirement that required employees to prove they should be accommodated. The process now flips the script so employers will now need to work with staff to provide accommodations. This law builds on the Pregnancy Discrimination Act and closes loopholes. This translates into birthing people not losing their jobs for taking needed time off to care for themselves, even if they have been employed for less than a year. On a topic of reproductive justice, on July 13th the FDA just approved Opill (norgestrel), the first oral contraceptive approved for use without a prescription. The decision comes at a time when nearly half of pregnancies in the U.S. are unintended and abortion has been restricted or banned in many states. It is a progestin-only pill that will be available at pharmacies and even online. For progestin-only contraceptives, there are few contraindications and very few safety concerns, and it's very easy for people to self-screen with the assistance of the pharmacist or online decision tools. Lack of access to contraception due to lack of access to providers negatively impacts women's ability to own their reproductive freedom. The downstream effects of unintended pregnancies, especially to BIPOC childbearing people, ranges from increased adverse perinatal outcomes to educational and financial barriers. #### **Growing IDEAS Program:**

At the 2023 National convention in New Orleans, the Regional DEI Coordinators facilitated an event called Growing IDEAS (Inclusive, Diverse, Equitable, Accessible Sections). This program engaged over 80 participants in two interactive activities. The first one, called "Identity Signs" helped to deepen attendees understanding about identity and belonging. People grouped themselves in accordance to aspects of their identity, in response different questions posed by facilitators. The aspects of identity were: gender identity, race, class, language, nationality, sexual orientation, and religion. Second activity was a program called Transforming Commitment into Action. The goal was to brainstorm meaningful, actionable items for nurses to implement in pursuit of the commitment statement on the front of the "Commit Card" each person received when they found a spot at a table. We only had a short discussion time to share ideas. So, we gathered up the Commit Cards and have since typed up the ideas that were brainstormed. We are in the process of reviewing these ideas and will email out the synthesized information soon. Obstetric Patient Safety: OB Emergencies Workshop 3rd Edition Despite efforts from many collaborating agencies and professional organizations, the maternal mortality rate in the United States continues to remain high. The Obstetric Patient Safety (OPS): Obstetric Emergencies Workshop 3rd Edition is designed to help clinicians identify, assess, and manage the care for patients with an obstetric emergency through simulation and debriefing.
