# AWHONN on Capitol Hill (AOCH), April 29-30, 2024

The bills! This is just a brief synopsis adapted from the AOCH briefs.

#### H.R. 5568 / S. 2846, The Community, Access, Resources, and Empowerment (CARE) for Moms Act

- The CARE Act for Moms supports the maternal health workforce, promotes prenatal and postpartum care access, and provides resources for mothers and infants.
  - Establish state-based Perinatal Collaborative grant programs.
  - Establish regional centers of excellence.
  - Support Federal efforts to grow and diversify the doula workforce.
  - Extend Medicaid coverage for postpartum mothers in all 50 states.
  - Establish grants for Rural Obstetric Mobile Units.
  - Extend Medicaid and CHIP to oral health coverage to pregnant and postpartum women.
  - Extend WIC benefits for postpartum and breastfeeding women for two years.

#### • S. 1573, The PREEMIE Reauthorization Act of 2023

- This bill offers continued funding of \$2 million annually through 2028 for the CDC to continue research and education outreach concerning the causes of PTL and how to improve outcomes for preterm and LBW infants.
  - Renew the CDC research programs on preterm birth, including national data tracking.
  - Fund activities focused on promoting healthy pregnancies and preventing preterm birth.
  - Research the impact of gaps in social factors on the monetary public health program to guide Health & Human Services (HHS) in making new recommendations to prevent preterm birth.
  - Create within the Department of HHS a new entity to coordinate activities and programs related to preterm birth, infant mortality, and other adverse birth outcomes.

#### • S. 2415, The Preventing Maternal Deaths Reauthorization Act of 2023

- This bill reauthorizes federal support for state based maternal mortality review committees through 2028. MMRCs review all pregnancy-related deaths to identify causes and recommendations to prevent future mortalities.
  - This bill would expand MMRCs to better protect women throughout their childbearing journey and assist in narrowing racial outcome disparities.
  - MMRCs are a multidisciplinary committee including: public health, OBGYNs, MFM, Nursing, Midwifery, forensic pathology, mental and behavioral health, patient advocacy groups, and community-based organizations.

# ACCOUNTABILITY, BELONGING & CULTURE Brandy Frye

The Code of Ethics for Nurses with interpretive statements is a cornerstone of professional nursing practice and outlines how the professional nurse should approach patient care. One of the core fundamentals of nursing practice is that "The nurse practices with compassion and respect for the inherent dignity, worth, and unique attributes of every person." (ANA, 2015). Different health factors contribute to health outcomes, such as length or quality of life. Typically, when people think about what makes a population healthy or unhealthy, we first consider health behaviors and the social determinants of health, not the clinical care people receive at the bedside. An accurate and comprehensive approach to health equity requires addressing the social and delivery system factors driving inequity. We must actively work towards dismantling belief systems and structures that perpetuate systemic racism in Nursing. In the spirit of inquiry and to better understand ourselves as well as the communities we serve, the CA AWHONN section leadership team is launching a pilot program in the late spring of 2024.   labor and delivery.
- Evidence-Based Practice: Fetal monitoring practices evolve based on research and evidence.
   Attending advanced classes ensures nurses stay updated with the latest guidelines and best practices, enhancing critical thinking skills
- Communication: Effective communication with the healthcare team is essential during labor.
   Nurses attending advanced classes learn how to collaborate with physicians, midwives, and other professionals to optimize patient care.
- Legal and Ethical Considerations: Fetal monitoring involves legal and ethical aspects. Nurses need to understand their responsibilities, documentation requirements, and potential liabilities.
